Q. What Is The Procedure For Admission?

Maharashtra B. Pharm Application Process

All the aspirants who qualify the required eligibility criteria for MHT CET must complete the Maharashtra B.Pharm application process. The State CET cell accepts application forms for the courses in online mode only. Therefore, all candidates are advised to visit the official website of <https://mahacet.org>, in order to fill and submit their application forms. In order to complete the application form, candidates will have to comply with the following steps:

1. All candidates are to register themselves on the website.
2. Once registered, candidates will be able to complete the application form.
3. All candidates are required to check the details entered in the application form, prior to completing the payment of the application form fee. No changes to the application form will be entertained under any circumstances, once the application fee has been submitted.
4. Along with filling in the application, candidates are to pay the MHT CET application fee. The Application form fee is non-refundable.
5. After the payment of the application form, candidates are to upload their photograph and signature, as per the guidelines mentioned by the State CET Cell.

Q. Which Exam Is To Be Given For Getting Admission?/ What is criteria/eligibility for taking admission in B pharmacy courses?

Apart from the nationality and domicile criteria, candidates are also required to have qualified the academic qualifications required for admissions to the courses. The academic qualifications for the test are as follows:

1. Candidates should have passed 10+2 in the stream of science from a recognised board of education with at least 50% marks (compulsory subjects like Physics and Chemistry with one other subject from Mathematics or Biology.) Reserved category candidates from Maharashtra must have secured 45% aggregate score in the subjects mentioned above.

AND

2. Candidates should have secured a non-zero score in the CET exam conducted by the Competent Authority.

3. For All India Candidates:

Candidates should have secured a non-zero score in NEET or equivalent CET exam, in all the subjects. The preference would be reserved for those who have a valid score in NEET over any other CET exam.

Q. Which Are The Subjects Included In 4 Years For B. Pharm. Course?

The subjects included in the 4 yr course includes the following subjects
Pharmaceutics, Pharmaceutical Analysis, Pharmacognosy and Phytochemistry,
Pharmaceutical Inorganic Chemistry, Pharmaceutical Organic Chemistry,
Pharmaceutical Microbiology, Biotechnology, Medicinal Chemistry, Physical
Pharmacy, Management, Pharmaceutical biochemistry, Active Pharmaceutical
Ingredient technology, Bioorganic Chemistry & Drug Design, Quality
Assurance Techniques, Pharmaceutical Jurisprudence. These subjects are
divided in the four year course.
