Revised Notice for Admissions in Vacant Seats after CAP-III for First Year B. Pharmacy



Eligibility: As notified by government and specified by appropriate authority, State Common Entrance Test Cell, Government of Maharashtra from time to time.

Note:

- **Candidate must be present in-person**
- The Candidate should bring print out FC confirmation or SC confirmation letter done on the State CET Cell website (Provisional allotment letter) with college admission receipt and bonafide certificate, in case the candidate has already taken admission in other college.
- The candidate should bring all original documents for the admission process. If a candidate is unable to produce original certificates at the time of his/ her admission on account of admission already secured in other institute, he/she shall produce the original bonafide certificate and photo copies of all such documents attested by institute. Such candidates shall be required to pay the fees (Candidate with Bonafide certificate, has to pay requisite fee immediately at the time of admission and such candidate shall be permitted to submit the required original documents on or before 23.12.2024 (5.00 pm) otherwise his/ her admission will stand automatically cancelled and fees paid shall be forfeited.
- The candidate has to cancel his/her earlier admission at his/her own risk and cost.
