- Candidate must be present in-person
- The Candidate should bring **print out FC Conformation or SC conformation letter done on the State CET Cell website** (Provisional allotment letter) with College admission receipt and Bonafide certificate, in case the candidate has already taken admission in other College.

If a candidate is unable to produce original certificates at the time of his/ her admission on account of admission already secured in other institute, he/she shall produce the Original Bonafide Certificate and Photo copies of all such documents attested by institute.
