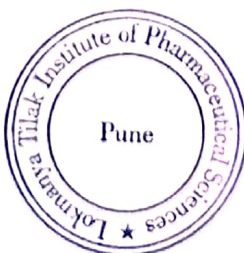

- **Candidate must be present in-person**
- The Candidate should bring **print out FC confirmation or SC confirmation letter done on the State CET Cell website** (Provisional allotment letter) with college admission receipt and bonafide certificate, in case the candidate has already taken admission in other college.
- The candidate should bring all original documents for the admission process. If a candidate is unable to produce original certificates at the time of his/ her admission on account of admission already secured in other institute, he/she shall produce the original bonafide certificate and photo copies of all such documents attested by institute.
